### **07/28/2025**

#### **Warrant Arrest 9455 W Loomis Rd - FRPD**

On Monday, 07/28/25, at 0951 hours, a subject out of Hales Corners was taken into custody on a warrant with the WI Department of Corrections for a Probation Violation.

### **Eluding, Recklessly Endangering Safety, Bail Jumping, Possession of a Controlled Substance 2500 Blk W College Ave**

On Saturday, 08/02/25, at 0121 hours, a resident of Franklin was taken into custody for Eluding, Second Degree Recklessly Endangering Safety, Reckless Driving, Bail Jumping, and Possession of Marijuana.
