The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

07/31/2023

Endangering Safety by Use of Dangerous Weapon, Carry Concealed Weapon W Drexel Ave/W Loomis Rd

On Monday, 07/31/23, at 0901 hours, a resident of Franklin was taken into custody for Endangering Safety by Use of Dangerous Weapon and Carrying a Concealed Weapon.
