The weekly roundup is back with a special double edition! Here is a list of notable events from the past 2 weeks!

Some incidents may have been omitted to preserve the integrity of an ongoing investigation or to protect a victim. Addresses are not specified in some cases, referred to instead by block.

The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

07/04/2022

Warrant Service S 27th St/W Drexel Ave

On Monday, 07/04/22, at 0302 hours, a subject out of Milwaukee was taken into custody for having a valid warrant with Waukesha County Sherriff's Office for Theft. This occurred pursuant to a traffic stop. He was later turned over to WKSO.
