The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

**Felon in Possession of Firearm, Possession of Controlled Substance, Possession of Drug Paraphernalia
