06/30/2025

Warrant Arrest 3800 Blk Heatheridge Dr

On Monday, 06/30/25, a resident of Franklin was taken into custody on a warrant with the WI Department of Corrections for a probation violation stemming from a Reckless Driving complaint received the previous evening. He was transported to County Jail.

On arrival, FRPD squads discovered a GDPD squad crashed into the traffic standard in the intersection. The squad sustained disabling damage and became engulfed in flames. FFD extinguished the fire without incident. The Officer was transported to an area medical facility for injuries.
