05/02/2022

Possession of Controlled Substance/ Felony Bail Jumping 6300 Blk S 27th St

On Monday, 05/02/22, at 0216 hours, a subject out of Milwaukee was taken into custody for Possession of THC and Felony Bail Jumping pursuant to a traffic stop. He was later turned over to County Jail.
