The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

05/29/2023

Traffic Crash S 76th St / W Ryan Rd

On Monday, 05/29/23, squads responded to a 2-vehicle traffic crash resulting in injuries.

Operating Motor Vehicle While Intoxicated – 3rd Offense 7130 S 76th Street - Walgreens

On Monday, 05/29/23, at approximately 1723 hours, in the lot of Walgreens, a subject out of California was taken into custody for Operate Motor Vehicle While Intoxicated – 3rd Offense. She later provided an evidentiary blood sample, the results of which are not yet known. She was booked, cited, and released to a sober party after posting bail.

On Tuesday, 05/30/23, a subject was taken into custody for Possession of THC pursuant to a traffic stop. She was booked, cited, and released.

Operating Motor Vehicle While Intoxicated - 3rd Offense, Traffic Crash W Puetz Rd/S 76th Street

On Thursday, 06/01/23, at 1958 hours, a resident of Franklin was taken into custody for Operating A Motor Vehicle While Intoxicated-3rd Offense. She later provided an evidentiary breath sample which indicated that she had a Prohibited Alcohol Concentration of 0.17. She was booked, cited, and released to a sober party. Charges were referred to the District Attorney's office for review.

Operating Motor Vehicle While Intoxicated – 1st Offense 8000 Blk Chapel Hill Dr

On Sunday, 06/04/23, a resident of Franklin was taken into custody for Operating a Motor Vehicle While Intoxicated – 1st Offense. This occurred after he struck a parked car with his vehicle, causing the struck vehicle to travel approximately 150 feet. He later submitted an evidentiary chemical test of his breath which showed he had a Prohibited Alcohol Concentration of 0.16. He was booked, cited, and released.
