05/05/2025

Possession of Controlled Substance/Drug Paraphernalia, Battery to Law Enforcement Officer Causing Injury, Resisting Arrest, Bail Jumping, Trespassing, Escape
9500 Blk W Loomis Rd

On Monday, 05/05/25, at 0843 hours, a subject out of Milwaukee was taken into custody for the above offenses. This occurred after he was found trespassing at the property, in possession of drugs and paraphernalia. As an officer was placing him in handcuffs, he became combative, striking the officer, causing multiple injuries. He fled but was soon located by other officers and taken into custody. He was on bail for previous felony arrests at the time of the incident. He was booked and transported to County Jail with charges referred to the District Attorney's office.
