# Here is a list of notable events from the past week!

Some incidents may have been omitted to preserve the integrity of an ongoing investigation or to protect a victim. Addresses are not specified in some cases, referred to instead by block.

## 11/15/21

### **Possession of THC S 27th St / W College Ave**

On Monday, 11/15/21, at 0529 hours, at S 27 St/W College Ave, a subject out of Milwaukee was taken into custody for Possession of Marijuana pursuant to a traffic stop for registration and equipment. Subject was booked, cited, and released from the substation.

### **Warrant Arrest 5801 W Franklin Dr**

On Monday, 11/15/21, at 1408 hours, a registered sex offender out of Milwaukee working in Franklin was taken into custody for having a valid felony Warrant with WI Department of Corrections for Probation Violation, original charge of 1st Degree Sexual Assault of Child. This occurred after FRPD received a request from DOC for immediate pick up of this subject on the violation. The subject attempted to flee from Officers out a rear door and was confronted by perimeter squads. The subject retreated back through the business and was apprehended shortly afterward in the front lobby of the business. The subject was turned over to personnel at the Milwaukee County Secure Detention Facility.

### **THEFT 6701 S 27th Street - Walmart**

On Monday, 11/15/21, at 1631 hours, a Walmart employee was taken into custody for Theft after they removed approximately \$825 in merchandise from the store without paying for it. The subject was released on bail with misdemeanor Theft charges being referred to the Milwaukee County DA's office.

**Operating Auto While Intoxicated  
4100 BLK W Drexel Ave**

On Tuesday, 11/16/21, at 1046 hours, a subject out of Milwaukee was taken into custody for Operating A Motor Vehicle While Intoxicated- First Offense. **Operating Motor Vehicle While Intoxicated -2<sup>nd</sup> Offense /Possession of Controlled Substance /Possession of Drug Paraphernalia
