

Traffic Crash
S 27th St/W Acre Ave

On Monday, 11/03/25, at 0705 hours, officers responded to a crash involving an automobile and a bicycle. The bicycle rider was transported to an area medical facility for treatment.

Motor Vehicle Theft 9375 S 27th St – The Modern 41 Motel

On Monday, 11/03/25, at 0949 hours, a guest at the motel reported that a woman who had been residing with him at the motel for the previous two days had taken his vehicle without consent.
