The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

### **Possession of Controlled Substance S 27th St/W Puetz Rd**

On Tuesday, 11/08/22, at 0153 hours, a subject out of Milwaukee was taken into custody for Possession of Marijuana. This occurred pursuant to a traffic stop.

Charges were referred to the District Attorney's Office for review.
