10/13/2025

Restraining Order Violation, Possession of a Controlled Substance/Paraphernalia 6500 Blk S Whitnall Edge Rd

On Sunday, 10/12/25, at 2355 hours, a resident of Franklin was taken into custody for Violation of a Restraining Order, Possession of THC, and Possession of Drug Paraphernalia. This occurred after she made contact with another subject at his residence in violation of a 72-hour No Contact Order stemming from a Domestic Violence incident. She was booked and transported to County Jail. Charges were referred to the District Attorney's office for review.
