10/06/2025

Stolen Vehicle Recovered 7780 S Lovers Lane Rd - Target

On Monday, 10/06/25, at 0726 hours, officers located a vehicle listed as stolen through the Milwaukee Police Department parked unoccupied in the lot of Target. The owner was notified and they retrieved the vehicle. MPD was advised the vehicle had been recovered.
