## **09/04/2023**

### **Operating Motor Vehicle While Intoxicated – 1<sup>st</sup> Offense W Rawson Ave/S 76th St**

On Monday, 09/04/23, a subject out of Muskego was taken into custody for Operating a Motor Vehicle While Intoxicated - 1st Offense. The subject provided an evidentiary blood sample, the results of which are not yet known at this time. He was booked, cited, and turned over to a sober party.

### **Warrant Arrest 8151 S 27<sup>th</sup> St – Plaza Motel**

On Monday, 09/04/23, at 0118 hours, at the Plaza Motel, a subject out of Cudahy, was taken into custody for having a valid warrant with the Florence County Sheriff for Contempt of Court and Disorderly Conduct. **Warrant Arrest, Possession of Drug Paraphernalia

On Tuesday, 09/05/23, at approximately 0047 hours, a subject out of Milwaukee was taken into custody for Possession of Drug Paraphernalia and for having a valid warrant with the Milwaukee County Sheriff's Office for Possession of Cocaine. This occurred pursuant to a traffic stop. She was later turned over to MCSO Deputies.

### **Eluding, Recklessly Endangering Safety, Bail Jumping, Criminal Damage to Property, Operating Motor Vehicle While Intoxicated – 1<sup>st</sup> Offense. 8800 Blk S 36<sup>th</sup> St**

On Saturday, 09/09/23, at 0244 hours, a resident of Franklin was taken into custody for Eluding, 1st Degree Recklessly Endangering Safety, Felony Bail Jumping, Felony Criminal Damage to Property, and Operating a Motor Vehicle While Intoxicated-1st Offense. This occurred pursuant to a traffic stop for Reckless Driving. The subject led officers on a 1.4 mile pursuit and crashed into a garage on the 8800 Blk of South 36th Street, causing a vehicle fire and extensive damage to the residence. He was transported to an area hospital for injuries where he submitted to an evidentiary chemical test of his blood, the results of which are unknown at this time. He was booked, cited, and turned over to County Jail with charges referred to the District Attorney's office for review.

### **Battery – Domestic Violence 6900 Blk S 51st St**

On Saturday, 09/09/23, at approximately 1321 hours, a subject was taken into custody for Battery – Domestic Violence related. This occurred after he struck his daughter in the face, causing injury. He was booked and released after posting bail. Charges were referred to the District Attorney's office for review.

This occurred after he spit blood on an FRPD officer's face, threatened to kill the Officer's family's, and resisted arrest. He was later turned over to County Jail.

S 27 St/W Puetz Rd**

On Sunday, 09/10/23, at 1927 hours, an FRPD Officer initiated a traffic stop on a yellow sport motorcycle. The motorcycle led Officers on a 1.2 mile pursuit which was terminated at I-94 and W Drexel Ave.
