# Here is a list of notable events from the last week!

Some incidents may have been omitted to preserve the integrity of an ongoing investigation or to protect a victim. Addresses are not specified in some cases, referred to instead by block.

The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

## **09/12/2022**

### **Possession of Controlled Substance, Bail Jumping, Possession of Drug Paraphernalia S 27th St/W Northwestern Mutual Way**

On Monday, 09/12/22, at 0259 hours, a subject out of Milwaukee was taken into custody for Possession of Cocaine, Bail Jumping (Felony), and Possession of Drug Paraphernalia. This occurred pursuant to a traffic stop. He was booked and transported to County Jail with charges referred to the District Attorney's Office.
