The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

09/26/2022

Mutual Aid -Greenfield PD S 43rd St/W Loomis Rd

On Monday, 09/26/22, at 0251 hours, the Greenfield Police Department requested Mutual Aid from our Drone Unit regarding a pursuit/crash in the area of S 43rd St/W Loomis Rd. The driver fled from the scene. The drone was deployed and several areas were checked. The subject was not located.

Retail Theft 6701 S 27th St -Walmart
